Community Services Recovery Fund Initiatives

Community Services Recovery Fund







The Government of Canada delivered the Community Services Recovery Fund through three National Funders – Canadian Red Cross, Community Foundations of Canada, and United Way Centraide Canada. The National Funders distributed funding to eligible community service organizations, including charities, non-profits, and Indigenous governing bodies, providing services in communities across Canada.

Muskrat Watershed Council was one of the many fortunate organizations to receive this funding, and we put it to good use in so many ways!

The following projects were funded by the Government of Canada's Community Services Recovery Fund...

Project 1: Turtle Nesting Boxes

Level 3 and Level 1 Environmental Technician students from Algonquin College's Waterfront Campus constructed 10 turtle nesting boxes for the Muskrat Watershed Council. These boxes are designed to protect recently-laid turtle nests from common predators, giving their offspring a better chance of survival. Many of these boxes were deployed this spring along predetermined sites within the Muskrat watershed.





Project 2: Benthic Invertebrates and Water Quality in the Muskrat Watershed Grade 9 science students from Opeongo High School met with Muskrat Watershed Council volunteers to learn about benthic invertebrates and water sampling within the Muskrat watershed. Many thanks to Algonquin College's Waterfront Campus for providing the sampling equipment and to the Community Services Recovery Fund for covering the transportation costs.

Project 3: Little Ray's Reptiles Zoo Inc. at Cobden Public School The Muskrat Watersheds Council partnered with Little Ray's Reptile Zoo to present on native wildlife to students at Cobden Public School. Students were able to witness native wildlife up close while learning interesting features about them and the important roles they play in our local environment.





Project 4: Purchased New Water Testing Equipment

Muskrat Watershed Council (MWC) purchased a Hariba-U52 multiparameter probe for water sample analysis. It measures things like water temperature, dissolved oxygen, turbidity and conductivity, all on one probe. It is also easy to calibrate.

MWC also purchased a fluorometer to measure chlorophyll as well as phycocyanins, which are found in the cyanobacteria that occur in some types of blue-green algae. Having the proper equipment to measure water quality means we will no longer need to outsource our water testing and we will have hard data to submit when we apply for grants.

Project 5: Planting on Four Properties

In November, with the help of Watersheds Canada's Natural Edge Program and the Muskrat Watershed Council, four Algonquin College Students - Josh Collins, Ashley Conrad, Ben Dennison, and Kian Robson completed a shoreline planting project at four different properties on Muskrat and Olmstead Lakes. The objective of these planting projects is to naturally enhance the shorelines within the watershed to prevent erosion, increase water quality, and promote biodiversity. We would like to thank the Algonquin College students who volunteered their time to plant these shorelines.



Project 6: Virtual Meeting Improvements

Muskrat Watershed Council purchased a new webcam and microphone. We also updated and improved our meeting guidelines and structure and trained all key contributors. We are seeing improvements in meeting efficiency, minutes and tracking of actions.

This collaborative provides a wide-range of benefits to farmers and rural landowners, including a team approach to maximizing cost-share funding in projects.

Muskrat Watershed Council is honoured to join this collaborative. Together we will work to empower and support farmers and landowners and improve the watershed.




























MWC Planted 4,000 trees

this spring with Watersheds Canada





This spring, with generous funding from Coors Seltzer Canada, and as part of the Change the Course initiative, Muskrat Watershed Council restored two acres of shoreline around Muskrat Lake and successfully planted 4,000 native shrubs, including fruiting species for birds. Change the Course is a multi-year initiative; assessments were done for last year's planting and all plants are doing well.

Creating vegetative buffers is a nature-based solution to reduce nutrient loading, release cleaner waters into creeks and rivers, stabilize soils which can erode from overland runoff and flood events, and create a vital wildlife habitat.

This collaborative effort underscores a strong commitment to environmental stewardship and community engagement.

Media and Communications A Year in Review

WEB SITE ANALYTICS

Over the past year, Muskrat Watershed Council has seen a 95% increase in new web site traffic, but with a low returning customer rate at only 5%. The MWC email marketing campaign traffic accounts for 59% of site traffic.

Visitor engagement is down over the past year, but the average site session remained relatively stable.

However, over the past 30 days we are seeing some positive indicators with visitor engagement increasing, and unique visitors up 9%, site sessions up 15%, and a significant climb in post and blog views.


SOCIAL MEDIA TRENDS

Over the past year our Facebook reach declined 41.9% and visits declined only slightly by 5.6%. Much of this decrease can be attributed to the Canadian news content ban on the social media sites.

Interestingly, our Instagram reach increased 57.1%, but profile visits were still down a little at 8.6%.


However, in the past 30 days we are seeing very positive trends in Reach and Visits in both Facebook and Instagram.






Lessons learned - Retrospective

Water Testing in the Muskrat Watershed

Muskrat Watershed Council's Promising Results and Call for Volunteers

Muskrat Watershed Council is thrilled to share that our water quality monitoring initiative, which began in May with our new testing equipment, is showing encouraging results. We have been analyzing water samples from several key locations around the Muskrat watershed, and by mid-July, we have already seen improvements in the percentage of dissolved oxygen. This is a positive sign for the health of our aquatic ecosystems.

Community feedback has also been heartening, with many noting the increased clarity of our local lakes this year. This improved water clarity is a promising indicator of the effectiveness of our recent environmental measures and the collective efforts of our community.





However, to get a more accurate and comprehensive picture of the watershed's overall health, we need to expand our testing efforts.

We are calling for volunteers to help us collect samples from additional locations around the watershed.

Your involvement will be crucial in providing the detailed data necessary for assessing and enhancing the health of our environment.

If you are interested in getting involved and are within the Muskrat Watershed area, we would love to hear from you.

Together, we can continue to make a significant impact on the health and clarity of our beloved watershed.




Volunteer of the Year - Barbara Green

Barbara Green, our current secretary, has a lifelong connection to Whitewater Region. She started her teaching career in Pembroke and has been cottaging on Muskrat Lake for over 40 years. She has been a volunteer with Muskrat Watershed Council since its very beginning, more than 10 years ago. In fact, she attended the Muskrat Lake Water Quality Symposium on October 5, 2013, the meeting that led to the formation of the Muskrat Watershed Council in February 2014.

Barbara had long been concerned about water quality in the lake, so when she heard about the symposium she knew she had to attend and offer her talents to the cause. Barbara brings a lot of great skills, experience and passion to MWC. She spent many years teaching French and English as a Second Language (ESL), was an ESL consultant, and managed to squeeze in a degree in Journalism, which led to many writing and editing opportunities. Barbara clearly has a passion for language and writing and a desire to make the world a better place.

Barbara started as a general volunteer with MWC, then worked as media director for a short time before becoming secretary in 2021. She regularly helps with writing and editing, volunteering at the charity Bingo and representing MWC at fairs and community events.

Ten years in, Barbara wishes we could eliminate algae blooms for good. She says it would also be great to get rid of invasive species like zebra mussels and reduce the impact of Canada geese and their droppings on our water quality.



Though we are making steady progress, these are long-term goals and it will take time to see meaningful change. Still, Barbara is not discouraged. She reminds us we have accomplished so much over the past 10 years, from planting thousands of trees and shrubs that reduce nutrient runoff into the watershed to partnering with government agencies, educational institutions and environmental groups. These collaborations are creating a critical mass of concerned citizens.

When asked why she continues to volunteer, Barbara says she is inspired by women like activist Maude Barlow who encourages us not to be overwhelmed by the size of the problem we are seeking to solve, and anthropologist Margaret Mead who famously said, "Never doubt that a small group of thoughtful, committed individuals can change the world. In fact, it's the only thing that ever has."
